Reminder about the Upcoming Tax Deadlines

- Extensions:
 - Partnership, S-Corp and Corporate Tax Returns Deadline is <u>September 16</u>!
 - Individual, Couple, Family and Small Business reporting on Schedule C of the personal returns are due <u>October 15</u>!
- If you have not given me everything for the September deadline, you are much less likely to have your return filed on time.
- For the October deadline I need your information ASAP- I do need a few weeks to complete your return. I have grown so much that bringing me your documents and expecting me to complete in one week, is no longer possible.
- <u>September 16</u> is the deadline for the 3rd Quarter Estimated Tax Payments!
- <u>September 30</u> is the end of the 3rd Quarter and Payroll Taxes and Sales Taxes will be due again in October.

NEW CLASS OFFERING IN DEVELOPMENT

We have been asked to create a course for business owners to understand their finances and bookkeeping, along with other general startup helpful information. QUICKBOOKS PAYROLL IS CHANGING!

I recently received notice from Intuit QuickBooks that the Payroll program is changing. In a pretty big way.

First of all the pricing is going UP... AGAIN.

Secondly they are moving to the process of not only taking the direct deposit net from your bank on the usual date for your payroll, but will also withdraw from your account all the associated taxes for that payroll and will submit that money to the respective agencies when due on your behalf. No longer waiting for the due date to file the return and make the payment, leaving you the ability to have the money in your account until the due date. This is the same process that ADP, Gusto and all the other online payroll processing companies handle the taxes. It is because of this, and having a few clients we help that do not use QuickBooks, that we are working on an additional partnership with ADP so that you will have the option for us to process your payroll using ADP software at a reduced software fee versus QuickBooks subscription and per employee fees.

We are also looking into other software options, but we already partner with ADP so a smooth transition is likely if we utilize that route for you.

BOI – BENEFICIAL OWNERSHIP INFORMATION REPORTING!

<u>If you filed for your new LLC in 2024</u>- you have **only 90 days** to go to **FinCen.gov** and report who your LLC company Beneficial Owner is. We are not able to perform this duty for you. It is a legal requirement, our business insurance will not cover us for doing the service on our clients behalf. It is a simple process and should not take you more than about 20 minutes to complete.

<u>If you opened your LLC BEFORE January 1, 2024</u> you have until the end of this year to go online to **FinCen.gov** and report who the beneficial owner is for your LLC. The end of the year is just around the corner- if you have not done so yet- you should hurry up and do it!

What happens if you don't?? The penalty is very high! \$500 per day, up to \$10,000.

MICHIGAN IS CHANGING THE PAID SICK TIME REQUIREMENT!

~YOU WILL BE AFFECTED IF YOU RUN PAYROLL~

Effective February 21, 2025.

Applies to all employers in Michigan with 1 or more employees, $\div J \div 1/5 = 0^{\circ} 6 \times 9^{\circ} r \div 2 \cdot 1/3 = 0^{\circ} u \leftrightarrow 7 \cdot 2 \cdot 2^{\circ} \delta \leftrightarrow 7 \cdot 2^{\circ} \delta \to 0^{\circ}$

Includes salaried (both exempt and non-exempt) and full and part-time hourly workers. Employees accrue sick time at a rate of 1 hour for every 30 hours worked.

Key Provisions of Michigan's Earned Sick Time Act

• Employees accrue sick time at a rate of 1 hour for every 30 hours worked.

• Businesses with 10 or more employees must allow at least 72 hours of paid sick time per year to be used to the extent the leave is accrued.

• Businesses with fewer than 10 employees must allow at least 40 hours of paid sick time annually, plus an additional 32 hours of unpaid sick time to the extent leave is accrued.

• Unused sick time can be carried over, but employers may limit annual use to no more than 72 hours.

• Employees have the right to pursue action if an employer interferes with or retaliates against their use of ESTA benefits, including through private action.

MICHIGAN MINIMUM WAGE IS INCREASING!


The current \$10.33 an hour minimum wage is set to jump to: \$12.48 in 2025, \$13.29 in 2026, \$14.16 in 2027, and \$14.97 in 2028 — a 45% hike over four years.
